With reference to the above cited subject, the Executive Engineer, Bangalore Water Supply and Sewerage Board had submitted a proposal in Form-A(Part-1) under section-2 of Forest (Conservation) Act, 1980 for diversion

of 2.4281ha of forest land in Sy.No.1/P of Kadugodi Plantation Village, Bidarahalli Hobli, Bangalore East Taluk, Bangalore Urban District for construction of Ground Level Reservoir(GLR) of 48ML capacity under JICA fund to provide water supply facilities to the newly added 110 villages coming under BBMP vide Contract Package-12 of Cauvery Water Supply Scheme(CWSS) Stage-V Project.

In ref(5), vide letter dated 22.02.2022. it was observed that 2.4281 ha of non-forest land in Sy.No.91, 125 & 134 of land in Thorekadanahalli Village, Malavalli Taluk, Mandya District has been identified by the User Agency for Compensatory Afforestation. The Topo sheet map with DGPS co-ordinates map has been submitted to the Deputy Conservator of Forests, Mandya Division, Mandya.

Further, the Deputy Conservator of Forests, Mandya Division, Mandya had been requested in ref(6) letters to send the suitability certificate for raising of CA plantation along with the financial outlay for CA scheme & relevant documents to this office. The same has to be uploaded in part-II, which is still pending in this division.

The Deputy Conservator of Forests, Mandya Division, Mandya had submitted his report stating that the CA land identified in Sy.No. 91, 125 and 134 of T.K.halli Village consists of 3meter wide underground water pipelines and also high voltage electrical transmission lines passing through the portion of identified CA land. As such, the land is not suitable for raising Compensatory Afforestation.(copy enclosed)

In view of the facts briefed above, I request your kindness to identify and provide an alternate land in Bangalore Urban District adjacent to the boundary of the reserve forests along with Topo sheet map & DGPS co-ordinates map at the earliest for further necessary action.
