

No.212 of W.P. (C) No.562 of 2009 after conducting joint survey of the proposed area.

3. Safety Zone map.
4. Details of approach road along with sketch.
5. Details of proposed conveyor belt if any along with sketch.
6. Certificate in Form-II of FRA 2006, issued by Deputy Commissioner, Ballari
7. Topo-sheet 1:50000, duly marking the area proposed for diversion.
8. Map showing broken-up area and virgin area (non broken area)
9. Land use plan of the diversion area in 1 : 25000 scale.
10. Map showing the details of protected area in 10 km radius from the boundary of area proposed.
11. Bare minimum area requirement certificate
12. Undertaking for payment of NPV & Additional NPV.
13. Undertaking for payment of Compensatory Afforestation amount and other charges.
14. Details of non-forest land to be transferred for Raising of Compensatory Afforestation (CA) & Additional CA along with copy of land registration.
15. Compliance to all the conditions imposed by the MOEF & CC, Government of India.
16. Compliance to all the conditions imposed by the Government of Karnataka.
