On scrutiny of the information furnished by the PCCF, Telangana it is revealed that, still few issues like **documentary evidence in support of forest area claimed to be diverted to the railways (both pre & post 1980), documentary proof regarding ownership of the land proposed for diversion as per the records available at revenue & forests department, reasons for including forest area wherein two railway lines already exists have been included in the forest area proposed for diversion under the subject proposal etc** are not clarified;




