**Subject:** Diversion of 3.26 hectare of forest land for the construction of link road from Dhani to Kharli Kms 0/0 to 9/345 within the jurisdiction of Bilaspur Forest Division, Bilaspur, HP.

Sir,

Please refer to your office letter No. PW/GHD/CB/WA/Forest Case/2020/320-21 dated 05.05.2020 on the subject cited above.

2. From the perusal of proposal folders received vide your office letter under reference, the following shortcomings have been noticed as under:

1. The road has been construction in violation of FCA 1980 as such Extent of violation and name of authority which is responsible for violation may also be intimated.
2. It may also be intimated as to whether this road is included in the list 2183 case or otherwise.
3. All the papers attached with as per instruction on the subject metter the document signed by the authority person by the user agency should be duly stamp marked alongwith date.
4. In part-I page numbering is done with lead pencil which required with ink pen.
5. Cutting and application of fluid in proposal folders is not accepted.
6. The said road is not appearing in the list of 2183 road proposals constructed in violation of FCA, 1980 whereas the said road has been inspected in view of CWP No. 5600 of 2012 of Hon'ble High Court of Himachal Pradesh. A detailed report on violation w.r.t. extent and reasons of violation in the form of self contained note supported by requisite documents, as required under para 1.9 of chapter I of FCA guidelines in required to be supplied by DFO concerned.
7. The Page No are not marked properly and not placed as per requirement of check list. Similarly the page no in part I of from A is to be mentioned accordingly.

9. Dumping has also been proposed over forest land hence as per latest instruction of Gol, the dumping site are required to be shown on KML file and map on toposheet and digital map in online part-I. Revised KML file, map on toposheet and digital map showing the dumping site are required to be uploaded against column C ii (b), C (iii) and C (iv) of online part-I.
10. KML file of the area proposed for diversion may also be provided in shape of CD/Pen Drive.
11. The colures documents placed in original folders should also be placed in other folder of the proposal.
12. Against column E(i) online, employment likely to be generated has been shown 72023 whereas, in part-I hard copy 2500 mandays are likely to be generated. Please clarify.
13. Against column C(iii), although a map on toposheet has been uploaded but there is no heading has been mentioned on the toposheet, thus it cannot be made out which alignment is the proposed alignment. Revised map with proper heading is required to be uploaded.

14. The enumeration list/abstract of trees proposed to be felled is required to be submitted in species- wise with local/scientific names in dia-class in the following format:-

16. The Toposheet & digital map uploaded on part-I are required to be counter signed by the under signed and then to be uploaded in online part-I. The toposheet uploaded online in not clearly visible.
17. The Justification for the locating project the forest land uploaded online in part-I is also required to be counter signed by the under signed..
18. The location of beneficiary villages has not been shown/ marked on digital map (hard copy).

You are therefore requested to attend the aforementioned observations and re-submit the proposal folders after doing the needful. Further, you are also requested that in future before submission of proposal folder, depute dealing hand of your office to get the proposal folders scrutinized in the office.
