Sub: Proposal for diversion of 48.782 ha of forest land for construction of 220 KV LILO Transmission line from existing LoC No.70 of 220 KV Malkangiri-Balimela Transmission line to 220/33 KV Grid Sub-station, Khairput, Govindpalli of OPTCL in Malkangiri district, Odisha. (**Proposal No. FP/OR/TRANS50828/2020**).

On scrutiny of the above diversion proposal for construction of Transmission line received vide your memo under reference, the following discrepancies are noticed.

1) In Part-II portion of the Application Form-A, details of 1331 numbers of trees has been uploaded in the portal at point No.4 (ii) i.e. Species-wise local / scientific names and girth-wise enumeration of trees at FRL.. But 1380 numbers of trees have been enumerated in forest land as per the enumeration list of trees furnished in the diversion proposal.

2) Abstract of tree enumeration list i.e. for forest land, non-forest land, private land and others should be furnished in the following format with seal and signature of the DFO.

No. of trees in forest land	No. of trees in private land	No. of trees in Govt non-forest land	Total	No. of trees to be felled / pruned.

3) In the Site Inspection Report of DFO at Point No.8, item-wise break up of forest land proposed for diversion has not been furnished though the user agency have furnished the information in the diversion proposal as given below-

Foundation casting area of towers in forest land = 0.284 ha.
Passing of transmission line conductor in forest land = 48.498 ha.
Total 48.782 ha.

4) In the Site Inspection Report of DFO at Point No.12, it is reported that a total of 1380 numbers of trees are to be felled . But in the diversion proposal, the user agency have furnished the information in this aspect as given below-

Type of land	Number of trees enumerated	Number of trees to be felled.	Number of trees to be pruned
Forest land	1380	885	495
Non-forest land	1158	698	460
TOTAL	2538	1583	955

In this regard the cases of trees enumerated, trees to be felled, trees to be pruned both in forest land and non-forest land may be verified from the records and report the facts for both the forest land and non-forest land in the site inspection report.
