
Sub: Diversion of 7 ha of forest land for establishment of Solid Waste Management Plant at Karsingsa-reg.

Ref: Your letter No.WAC/FCC/89/2023/543-45 Dated 14.02.2023

With reference on the subject mentioned above, you have submitted a proposal for diversion of 7 ha. of forest land for establishment of Solid Waste Management Plant at Karsingsa in favour of Itanagar Municipal Corporation. The examination of the proposal reveals the following short-comings.

1. DFO, Banderdewa vide his letter dtd 28.01.2022 reported you about the illegal earth cutting by Itanagar Municipal Corporation. Further an offence was drawn in instant case and was reported to PCCF office vide letter No.SUB/01/2022/Cons/539-40 dtd 21.02.2022. PCCF (A & V) & NO (FCA) vide letter of even no. dated 20.04.2022 directed DFO, Banderdewa to send copy of offence report drawn against the violators. DFO, Banderdewa was further asked to submit report on violation of Forest (Conservation) Act, 1980 in requisite format for onward submission to Govt. of India. Now, in instant proposal neither you nor DFO, Banderdewa has given any details about the above offence. The DFO, Banderdewa in Part-II has reported that there is no violation of the Forest (Conservation) Act, 1980. The DFO, Banderdewa may clarify why misleading information have been submitted. He may further submit the detailed report on violation of Forest (Conservation) Act, 1980 in requisite format.
2. The proposed area is within the ESZ of Itanagar WLS. Wildlife Clearance will be required. Status of the same may be given.

Therefore, in view above you are requested ask concern DFO to make modification in Part-II and re-submit the same to this office at earliest.


