With reference to the subject and letter cited above, I am directed to inform that the information furnished by the State Govt vide letter under reference above has been examined in this office and found incomplete. The lacking information observed are as follows:-

- The Cost Benefit Analysis of the proposed diversion as per the prescribed format (i) of Ministry's letter dated 01.08.2017 as the submitted format is incorrect.
- (ii) To clarify on the change of alignment of the proposed area as it is observed that the alignment has been changed from the original proposed site and moreover, the alignment shown in the corrected shape file involved more of forest cover as per the DSS analysis.

State Govt is requested to kindly furnish the above information to this office at the earliest for further processing of this proposal.
