Sir,

Please refer to the subject and reference cited above, wherein the State Government has forwarded the subject proposal and requested to accord approval under FCA, 1980. In connection to that, I am directed to request to furnish the following additional information / documents at the earliest for further consideration of the proposal;

- Certificate from the User Agency in support of the competency / authority of the person making the subject proposal application on behalf of the User Agency;
- Component wise breakup of the activities / structures to be built in the temple portion has not been reported. It appears that additional area than the area already utilized has been proposed for diversion. Hence the forest area proposed does not appear to be the barest minimum;
- Initial part of the road from the RF boundary has not been included in the proposal. Hence, the same may be clarified / rectified;
- Annexures a to h related to RoFR certificate may be furnished.
