- 1. Abstract and Enumeration list of trees placed in the proposal folder is not found as per instruction of Gol letter No. RO-DDN/GUIDELINES/01/2018/381 dated 23.09.2019 conveyed to you vide this office endst. No. FCA(Misc.)Inst.Vol.II/8402-06 dated 16.11.2019.
- 2. Inspection report of DFO is not found uploaded on its appropriate column.
- 3. As per revenue papers Kh. No. 454 Mohal Ogli under the possession and ownership of Irrigation and Health Department. This needs to be deleted from the check list No. 6.
- 4. The area proposed for diversion in Check list No. 6 and non availability of non forest land certificate does not tally with each other as well the total of the same is also incorrect.
- 5. Soft copy of the KML of area proposed for diversion is not submitted with the file.
- 6. Certificate to the effect that land in question recorded in the check list No. 7 (i.e. list of private/ non forest land) has not been recorded as 'Forest' in the revenue record needs to be furnished by the DFO concerned.

- 12. Proper muck management plan not placed in the proposal folder.
