Authenticated Maps and documents to be furnished

1. Check list in the prescribed format alongwith specific information
2. The shape file & KML file of the proposed forest land to be diverted (in CD)
3. RoR copy of proposed forest land to be diverted.
4. Authorized signatory of UA on each document.
5. Land schedule for non-forest / forest land in proper format with due signature of concerned Tahasildars and UA. (copy enclosed)
6. Length and width of pipelines passing through forest and non-forest area to be given by User Agency.
7. Rout map of proposed pipeline for the district of Bhadrak

Undertaking / Certificate to be furnished

1. Certificate regarding KISSAM of the non-forest land as on 25.10.1980 to be given by Tahasildar.
2. An undertaking duly signed by the User Agency to submit Stage-I compliance within one year of the Stage-I approval/before expiry of working permission.


In view of above, the hard copy of the diversion proposal in four set is returned herewith for necessary compliance on the above deficiencies.
