Sub: Diversion of 6.05 ha of Forest Land for Construction of Road from Shikari to Bhaller, Package No. JK14-114, Stage Ist, Phase Xth , District Reasi , U.T. of Jammu & Kashmir.-reg.

Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of **6.05** ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the Govt of J&K the following information/clarification are still required to be submitted:

- (i) Complete village wise break-up of forest land is not provided in Part-I.
- (ii) Undertaking to pay Addl. NPV is not given.
- (iii) Component wise break up of forest land not provided under column B. 2.4 of Part I.
- (iv) Nodal Officer to specify name of proposal and area proposed in Part-IV.
- (v) Specific recommendation from UT Govt of J&K is not provided.
- (vi) Incomplete Enumeration list, need to provide list with complete 103 trees.
- (vii) Site specific CA estimate with Technical/Administrative approval of competent authority to be submitted.
- (viii) Revised KML of the proposal to be submitted since the area of KML is significant less at 2.73 ha as opposed to proposed area of 6.05 ha which renders it difficult for proper analysis. KML does not match properly with the DGPS map. Three dumping sites are shown in the KML as opposed to 09 dumping sites seen in the DGPS map and also in the lay-out map.
- (ix) Maps of alternative routes examined to be provided.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
