Sir,

In reference to your above mentioned letter where approval for above referred forest land diversion proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. As per the information provided at A-3(xvii) regarding copy of documents in support of the competence/authority of the person making this application to make application on behalf of the User Agency, the signature of authorised signatory has not been attested.
2. The proposal is submitted for diversion of 6.35 ha but at various places it is mentioned as 6.348 ha or summation of village wise breakup are 6.348 ha. This needs correction and resubmission.
3. The proposed forest land on SOI topo sheet is shown as single segment whereas village wise break shows existence of forestland in two villages Devnagar & Kanas. This issue needs explanation.
4. The map showing alternative examined {uploaded at D(a) in part I } neither depicts forest area involved in each alternative nor proposed alignment.
5. Duly filled part V has not been provided with the proposal.
6. Xerox copies of documents pertaining to FRA 2006 have been submitted with the proposal.
7. The hard copy of the proposal is without compensatory afforestation scheme and CA scheme submitted online is without incorporating cost escalation due to inflation.
8. On several documents submitted with the proposal name and date has not been provided with the signature of signing authority.

Therefore, the proposal is hereby placed under EDS category for rectification/revision of the same as per the observations made above in point wise manner.
