विषय: Diversion of 0.2896 ha (instead of 0.3448 ha) of forest land in which the quarry site is only 0.1964 ha in favour of Bushahr Laghu Udyog, Pashada for mining and installation of stone crusher under Rampur Forest Division, District Shimla, H.P.

संदर्भ: नोडल अधिकारी एवं अपर प्रमुख मुख्य वन संरक्षक (एफ.सी.ए.), हि.प्र. के पत्र दिनांक 15.02.2019

उपरोक्त सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त निम्नलिखित कमियाँ पाई गयी हैं।

1. The details regarding raw material availability and source is not much described in this proposal. Therefore, the state govt. may submit the following information along with all relevant documents:
(a) Details of mines from where the raw material would come to this crusher unit;
(b) Distance of each of such mine from the crusher unit;
(c) Validity period of lease of each such mine;
(d) Validity period of forest clearance and Environment Clearance of each of such mine;
(e) Approved annual production of each of such mine;
(f) Production during last three years of each of such mine.
2. In the earlier proposal vide letter dated 12-10-2005 the state govt. informed that the distance of the present area is 10 km from Daran Ghat Wild life Sanctuary and 8.5 Km from Rupl Bhasa Wild life Sanctuary while in recent document of DFO it is more than 15 Km away from nearest sanctuary appear contradictory. Therefore, State Govt. may submit the CWLW certificate in this matter.
3. State Govt. may submit the Fresh NOC of village 'Pashada'.
4. State Govt. may submit the FRA certificate with all annexure in the prescribed format for non-linear projects.
5. State Govt. submit the copy of certificate approval issued by Govt. of H.P. Industry Department for establishment of stone crusher is required which is valid for the period of time for which approval is asked.
6. State Govt. may submit the certificate duly authenticated by the DFO that the rest of the land other than proposed for establishing stone crusher & approach road is beared with forest department.
7. The State Govt. may clarify that the project attract provisions of EIA notification 2006 if yes the details regarding status of EC may also provide in this office.

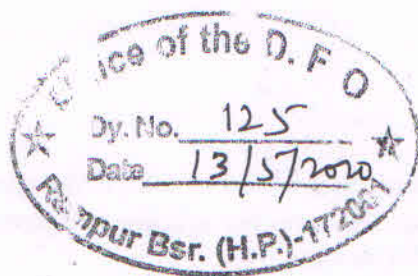

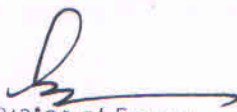
