Subject: - Diversion of 2.1532 ha. of forest land for mining lease approach road and stacking of raw material for already established stone crusher at Pashada, PO Khaneri, Tehsil Rampur Bushahr, Distt Shimla H.P. in favour of M/s Bushahr Laghu Udyog VPO Jhakri, Tehsil Rampur Bushahr within jurisdiction of Rampur Forest Division, Distt Shimla, H.P.

Please refer to your office letter No. 247 dated 12.05.2020, on the subject cited above.

2. The reply to the observations in the aforesaid case has been scrutinized and it is observed that same is not satisfactory and prepared in hasty and slipshod manner. The following shortcoming/discrepancies have been noticed in the revenue papers:-

1. खसरा न0 22/1 में रकवा तदादि 0.3520 है0 में material stacking and approach road के लिए भू0 अधिग्रहण किया है यह चैक लिस्ट 6 में दिखाया गया है। परन्तु रकवा खसरा न0 22/1 में सड़क का ततिमा नहीं काटा गया है। अब सड़क का ततिमा काटा जावे।
2. खसरा न0 13/1 में सेफटी जोन का रकवा भी नहीं दिखाया गया है। अब सैफटी जोन का रकवा भी दिखाया जावे क्योंकि माईनींग व सैफटी जोन का रकवा खसरा न0 13/1 में इकटा दिखाया गया है। अब अलग-अलग दिखाया जावे।
3. खसरा न0 14/1 जो मौके पर नाला है जो चैक लिस्ट 6 में अपरोच रोड़ दिखाया गया है यह भी गलत है।
4. जो अपरोच रोड़ खसरा न0 14/1 में दिखाया गया है। वह सड़क मार्ग से 75 मिटर की दूरी पर स्थित है। खसरा न0 14/1 में जो अपरोच रोड़ दिखाया गया है वहां तक पहुंचने के लिए राजस्व रिकार्ड भाजरा में उसका ततिमा नहीं काटा गया है। जो NH-सड़क तक जोड़ा जाना है। अब इसका ततिमा काटा जावे। अतः नाले में सड़क बनाना सम्भव नहीं है।
5. फिल्ड बुक में जो इस्तखराज रकवा निकाला गया है उसका वदस्तूर रकवा फिल्डबुक में नहीं लिखा गया है। अब वदस्तूर रकवा फिल्ड बुक में लिखा जावे।
6. Besides this, the following shortcoming/discrepancies have also been noticed
 - i) In the checklist No. 3 & 9 placed in the proposal folder, it is not mentioned that already established crusher is presently functioning or not. Please intimated status of stone crusher, whether it is in a functioning position or other wise
 - ii) The forest land 0.2898 hac. has already been diverted in favour of the User Agency for mining and installation of stone crusher vide MoEF & CC letter No. 9-HPB-414/1997 -CHA/3593 dated 18.08.2006. Please intimate the status of reclamation of forest land that are exhausted minerals to this office.

- iii) The safety zone area of 7.5 meter wide peripheral within the mining lease has not been shown in the digital map/ SoI Toposheet & KML Map.
- iv) The component wise breakup of safety zone area as shown in para B 2.4 online does not tally with the area shown in the check list No.6.
- v) The width of 10 meter and 50 meter strip on either side of pubic road and natural streams respectively located inside the mining lease has not been shown in the revenue papers placed in the proposal folders as well as in the Map. Please justify.
- vi) The plantation scheme may also be prepared as per one and half times of the safety zone area actually proposed for diversion.
- vii) The KML file of the land proposed for diversion has also not been uploaded in view of GoI observation in point No.3. Please see to it.
