With reference to your memo cited above on the subject, the proposal submitted by you in respect of Kalarangiatta Chromite Mines of M/s FACOR Ltd. needs compliance on the following points.

- (1) The C.A. scheme on the non-forest land over an area of 23.80 ha has been made in Block Plantation Module. However, the Topo-sheet indicates that the area is located on a hillock and the R.O.R./Kisam of the said land is 'Parbat' as per the records furnished by the Tahasildar, Kankadahad, Dhenkanal District. Therefore, the C.A. scheme needs to be formulated in the 'Bald hill' module following the norms specified and approved by the Principal Chief Conservator of Forests, Odisha vide his Memo No.1769 dated.29.01.2016.
- (2) The Certificate from Collector, Jajpur under Forest Right Act 2006 has not been furnished. The Forest & Environment Department, Govt. of Odisha vide their letter dated 26.5.2016 has asked for certain clarifications in the matter which needs to be furnished.

Therefore the proposal submitted vide your memo under reference is returned herewith in five sets for necessary compliance and resubmission.
