- 2- The Topo Sheet, DGPS Map with KML file for the land identified and selected for raising Compensatory Afforestation for the project is wanting.
- 3- The RoR of the land (both Hal and Sabik record) issued by the concerned R.I. and authenticated by the Tahasildar, Bahalda and DFO, Rairangpur identified for raising Compensatory Afforestation is wanting.
- 4- Non-encroachment certificate issued by the Tahasildar, Bahalda of the land identified for raising compensatory afforestation is wanting.
- 5- The area over 35.787Ha. in Soso Mouza under Bahalda Tahasil has been identified for raising compensatory afforesttion for the project. Hence, the Part-II of Form-A and Site Inspection Report of DFO, Rairangpur Division should be modified accordingly.

You are requested to comply the above points and submit 04(Four) sets of the documents alongwith your compliance report to this office immediately for taking further action at this end.
