Submission of proposal for diversion of 136.966 ha (94.013 ha in Baliguda Forest Division & 42.953 ha in Kalahandi North Division) of forest land for non-forest purpose under Forest Conservation Act, 1980 for construction of 220 KV DC Transmission line from existing 220/132/33 KV Grid Sub-station at Kesinga, Kalahandi District to proposed 220/32 KV Grid Sub-station at Sirtiguda in

Kandhamal.

Sir,

With reference to the above cited letter on the captioned subject, during site inspection of the non-forest lands of the aforementioned project on 27.06.2023,

- 1. it is ascertained that, the trees in girth under-30 cm (pole) have not been enumerated from the entire corridor. You must contact the Divisional Manager, OFDC LTD, Bhawanipatna(C-KL) Division to undertake enumeration of under-30 cm Girth (pole).
- 2. The towers have been erected in the different village forest as reported the Range Officer, Kesinga vide his memo No. 533 dt. 06.07.2023 (details with map enclosed).
- 3. The numbering of the enumerated trees is not properly legible which would create issue for the OFDC. Ltd. during felling of trees. Wherever the numbering is not visible, it must be done properly with good quality paint.
