

Sub: Diversion of 22.36 ha of forest land in favour of Sub Divisional Officer, Construction Sub Division No. 9, Irrigation and water Resources Deptt. Jagadhary for the Remodeling of Augmentation Canal from RD 0.00 Km (Hamida head) to 75,250 km. (sub Reach 0 to 20 Km), under Forest Division and District Yamunanagar (Online proposal no. FP/HR/Canal/41159/2019).

Sir.

I am directed to refer to online proposal forwarded by the Nodal Officer (FCA), Government of Haryana on the above mentioned subject seeking prior approval of the Central Government for diversion of 22.36 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

- 2. After careful examination of the above mentioned proposal of the State Government, the following information/clarifications are still required to be submitted:
  - i) Undertaking from U.A to pay NPV be provided.
  - Mutate and transfer of non forest land in favour of Forest Department and declared it as PF/RF.
  - iii) DGPS map pdf and CA site is not matching with each other. In DGPS map total CA sites are Nineteen were as KML uploaded on portal is Eighteen. The Missing KML on online portal is CA site Kaulana Distributary RD 60-120 L/R which needs to be uploaded for DSS analysis.
  - iv) In Serial No. 14 under column 13(i) of part II online, three KML features are uploaded under one KML i.e., Kulwana 1, Kulwana 2, Kulwana 3, but in DGPS map Kulwana 3 geo-coordinates is missing. Revised DGPS map be uploaded.
  - v) DSS/google earth shows that out of 22,360 ha as provided by the UA/SG of 14 CA sites as shown below only 19,340 ha area/space is available for CA plantation. Additional 3,020 ha is required for target plantation for CA and accordingly DGPS map, KML file, SOI toposect of the site be provided and uploaded. DSS Analsysis of the 14 sites with availability of space is as under:
