With reference to the above cited correspondence on the subject, it is to inform that the Addl. Principal Chief Conservator of Forests ,Forest Diversion & Nodal Officer,FC Act has returned the above forest diversion proposal vide his memo No. 9939 dt. 01.06.2019 with the following objections which may be complied with immediately

- i. The certificate regarding Hal/ Sabik Kissam of non-forest land schedule as on 25.10.1980 has not been furnished by the Tahasildars.
- ii. The slurry pipeline passing through forest and non-forest area has not shown in the layout plan.
- iii. The length of slurry pipeline passing on water pipeline corridor and on R&B road have not provided in the DP.
- iv. The latitude and longitude of the beginning and end points of the slurry pipeline has not been provided in the DP.

In view of the above the said forest diversion proposal received from the RCCF, Angul vide his memo No. 2416 dt. 13.06.2019 is returned herewith in 6(Six) sets to comply the deficiencies as pointed above and re-submit the same to this office for early processing of the proposal. Encl:- As above.
