- 4. The details regarding the Agricultural lands, Pucca Road and few Built-up area within the forest land sought for diversion has not been submitted and same needs submission.
- 5. As per DSS analysis, the user agency has uploaded incorrect KML file of the submergence area as total area of the submergence zone as per the KML file is found 158.628 ha whereas the total submergence area as mentioned in the proposal is 138.68 ha (69.58 ha Forest land + 69.1 ha Non-Forest land). Moreover, the correctness of the submergence zone KML file shall be cross-verified as part of the proposed forest land (forest area for submergence) KML file is falling outside the submergence zone and proposed forest land for waste weir construction is falling inside the submergence zone KML file.
- 6. The contour map/digital elevation model specifically showing the boundary of instant project has not been submitted and same needs submission.
- 7. As per the DSS analysis, the CA patch namely Village Saklon, Khasra No. 1/1 comprising an area of 1.914 ha is falling in the forest land. Further, the said CA patch is found isolated and having area less than 5 ha. The State Govt, was requested for revision of same. However the same is not revised. Keeping the same in view, the state government is requested to do the needful with regard to the revision in the CA site as above. - The present proposal is for diversion of 70.88 ha forest land against which the District Collector vide order dated 01.08.2022 allotted only 60.162 ha revenue land. Hence, there is variation of 10.718 ha area of land given for CA has been observed. The above variation needs clarification. Further, the documentary evidence/revenue record indicating that the area proposed for compensatory afforestation is nonforest land and is free from all encumbrances shall be submitted.
- 2. Satellite imagery shows the presence of Agricultural lands, Pucca Road and few Built-up area within the forest land sought for diversion. This needs clarification.
- 3. As per the DSS analysis, the CA patch namely Village Saklon, Khasra No. 1/1 comprising an area of 1.914 ha is falling in the forest land. Further, the said CA patch is found isolated and having area less than 5 ha. The same needs revision.
- 4. Proposed CA patches are having encroachment of Agriculture land. In this regard, the State Govt. shall examine the suitability of proposed CA land as per Rule-13 of the Van (Sanrakshan evam Samvardhan), Rules2023 and submit a report.
