


The above proposal was placed before the 40th Regional Empowered Committee (REC) held on 17.06.2021 for consideration and the REC noted the salient features of the proposal as under:-

- (i) This is the proposal for construction of Western Bypass from Karnal-Kaithal road to Munak road on left bank of WJC main branch from RD 81426 to 96000;
- (ii) The legal status of the forest land proposed for diversion of 5.30 ha is strip Protected Forest.
- (iii) As the proposal envisages construction of bypass road, there is no other alternative possible for the project avoiding forest land .
- (iv) The proposed alignment is not passing through any National Park, Wildlife Sanctuary, Elephant /Tiger Reserve.
- (v) The requirement of land is unavoidable and barest minimum.
- (vi) No violation of Forest (Conservation) Act,1980 is there as per DFO's site inspection report.
- (vii) No rare /endangered/vulnerable and endemic species of flora and fauna have been found/ recorded in the area.
- (viii) No sacred grove or very old growth trees/forests exists on the site and the forest land proposed for diversion is not having any socio-cultural/religious value.
- (ix) There is no Protected Archeological /Heritage site/Defence establishment in the proposed area for diversion.
- (x) The proposal involves felling of 488 trees and 4,000 plants.
- (xi) Compensatory Afforestation (5.3 ha) and Addl. CA (8.0 ha) has been proposed at 9 sites on NFL and 1 site on degraded forest land namely:

(xii) This proposal was examined in the Regional Office & following observations were raised on 08.04.2021, which were replied by SG on 17.06.2021. The point wise details are given below:

3. The REC examined the proposal online and sought following clarification:

- i) As per area calculation, area required for proposed diversion is 5.33 ha instead of 5.30 ha that needs to be corrected either at online portal or in area calculation.
- ii) Correction be made in employment likely to be generated under column E in part-I.
- iii) Certificate from UA to transfer NFL in favour of forest department be provided, as 9 number of NFL are proposed to be transferred/mutated in favour of Forest Department belonging to PWD.




