Please refer to the State Government's letter No. 1726/FCA/F&ED/149 dt.09.06.2020 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The State Govt. is requested to provide following additional information for further processing of the case:

- 1) The soft copies KML/Shape file of the proposed diversion area and Compensatory Afforestation area along with accurate GPS Co-ordinates to be furnished by State Govt.
- 2) The detailed purpose-wise break-up of forest land proposed for road diversion with length and width and Right of Way may be furnished.
 - The quantity of muck to be generated with GPS co-ordinates of muck disposal site(s).
- In PART -II Sl. no. 12 the total area diverted and C.A area stipulated has not been 4) mentioned. This may be quantified.
- The scheme for Avenue Plantation along the proposed construction of new approach road, if any may be submitted.
