Sir,

I am directed to refer to online proposal forwarded by the Nodal Officer (FCA), Government of Haryana on the above mentioned subject seeking prior approval of the Central Government for diversion of 31.33 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980,

2. After careful examination of the above mentioned proposal of the State Government, the following information/clarifications are still required to be submitted:

- In column B-1, in proposal submitted in past, One old online corporal FP/HR/road/21791/2016 of same user agency is still pending which is shown as "in-principle".
- Mutate and transfer of non forest land in favour of Forest Department and declared it as PF/RF.
- DSS/ google earth image found that proposed diversion land is violating one of Decision rule no. of DSS i.e., hydrological layer, Need to verify.
- Composition of major species existing on the proposed NFL for C'A and AC'A with details of their nature whether planted or naturally grown.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.
