Diversion of 4.9069 ha. of forest land in favour of M/s CLIEF FINVEST PRIVATE Ltd., 1-41, DFL, Industrial area, Phase-1, Faridabad, Haryana-121003, for the construction of 5.00 MW Thaltukhod Stage-1, SHEP, within the jurisdiction of Jogindernagar Forest Division, Distt. Mandi, Himachal Pradesh. (Online Proposal No. FP/HP/HYD/25572/2017)

महोदय.

उपरोक्त संदर्भित पत्र द्वारा प्रस्तूत प्रतिउतर का ध्यानापूर्वक अवलोकन करने के पश्चात प्रस्ताव में अभी भी निम्नलिखित कमियां पाई गई है:-

- 1. The detailed Muck Management Plan showing muck dumping site wise-area, dimensions, capacity, muck to be dumped etc. is required to be submitted in tabulated form and uploaded as well.
- The Reclamation Plan is required to be uploaded in the portal.
- The components mentioned in KML file and component wise-breakup are not matching with each other. Therefore, components proposed in the proposal are required to be identically marked/mentioned in KML file, Layout Plan, Geo-referenced map, toposheet and in component-wise breakup.
- The component wise-area, dimension, Khasra number for proposed diversion in Forest and Non-Forest land is required to be uploaded.
- 5. The status of CA land may be provided whether it is notified as Waste Land under HP Govt. notification, 1952 or notified as UPF/DPF under IFA, 1927. The documentary proof of notification may also be provided.
- 6. As per CWLW, the aerial distance of proposed site from Nargu WLS is 01 km, however as per DSS analysis by this office shows that proposed site falls inside Nargu WLS. Therefore, comments regarding variation of aerial distance as provided by CWLW and DSS analysis may be provided. Also, aerial distance of proposed site from boundary of Nargu WLS and its notified ESZ may be re-verified.
- 7. The components of proposed project are not found marked in toposheet. The same may be reviewed and toposheet with all proposed components be provided and uploaded as well.
- 8. The Geo-referenced map has been provided, however, same is not found uploaded in readable form. Therefore, Geo-referenced map with all proposed components in distinct colours and in legible form may be provided/uploaded.

- 9. A Geo-referenced map and KML file showing boundaries of nearest PA and its ESZ, location and distance of HEPs within 10 km of nearest PAs and its notified ESZ may be provided.
- 10. A list of approved/existing/proposed project in the landscape showing evacuation/transmission plan, distance from nearest PAs and its ESZ along with their impacts may be provided.
- 11. As per DSS analysis, polygon of diversion area is haing Very Dense Forest (VDF) category of more than 01 sq km. Therefore, same may be reviewed and density of vegetation of diversion area may be revised accordingly, if required.
- 12. As per DSS analysis, 01 hac area out of 05 hac proposed in DPF Khaban falls in Moderately Dense Forest (MDF) category. Therefore, same may be reviewed and if required, CA area may be replaced with other CA area with density less than 0.4.
- 13. It has been observed from the KML file, that area proposed for diversion is 2.28 ha, however, as per proposal, proposed diversion area is 4.9069 hac. Therefore, same may be reviewed and revised KML file with correct area figure may be uploaded.

You are therefore requested to kindly ensure that proposal may be thoroughly scrutinized, reviewed and revised keeping in mind the suggestions given by the MoEF&CC, New Delhi vide File no! 8B/HP/01/147/2019/FC, OM dated 13.05.2022 regarding the Hydel projects of Himachal Pradesh. The compliance of above observations is required to be uploaded in PARIVESH portal at designated locations.
