reference 7<sup>th</sup> cited. *T* The Divisional Forest Officer, Chintur is requested to  
go through the instructions issued vide reference 7<sup>th</sup> cited. In the  
reference 7<sup>th</sup> cited, the Prl.Chief Conservator of Forests, Andhra Pradesh,  
Guntur has informed that the proposal *was* ~~has~~ re-examined and submitted a  
report stating that, the proposed road project would lead to further  
encroachments by Gothikoya non-local tribal migrated from Odisha and  
Chattisghar States and there is no necessity for providing BT road from  
Alligudem to Staffordpeta which will adversely affect the forest wealth  
situated in the vicinity of the proposed forest land for diversion.

Further the Prl.Chief Conservator of Forests, Andhra Pradesh,  
Guntur has informed that the report is not comprehensive with respect to

the threat to forest conservation and may re-examine the proposal and instructed to submit a detailed report for taking further action.

In this context, the Divisional Forest Officer, Chintur is requested to re-examine the proposal and submit a detailed comprehensive report along with the details as requested by the Prl.Chief Conservator of Forests, Andhra Pradesh, Guntur vide reference 8<sup>th</sup> cited, to this office for onward submission to the Prl.Chief Conservator of Forests, Andhra Pradesh, Guntur for further course of action.
