

चमोली-पलडी-सरतोली रॉ चलयपर मोटर मार्ग :-

PROPOSAL NO. FP/UK/ROAD/16517/2015

1. Total period for which the land proposed to be diverted is not correctly mentioned in online Part I.
2. The copy of GIS software generated geo referenced digital map is not uploaded in the designated column in Part I and the map uploaded is google map which does not serve the purpose. The correct map showing geo coordinates at 200 to 300 m interval along the alignment of the proposed road including all turning points may be provide/upload showing digitally marked geo-coordinates on the map placed in the designated column in online Part I.
3. The digital map of area proposed for CA is provided with only four geo-coordinates shows on google map which does not serve the purpose. May provide/upload GIS software generated geo referenced digital map of the area proposed for CA providing geo coordinates at all corner points in shape (polygon/closed area) file.
4. If this project involve boundary of seven villages as mentioned in the list of villages to be benefited and village wise break up provided with the proposal then proceedings of village level committee (VLC) meeting pertaining to other villages may also be furnished with the FRA certificate. The FRA certificate uploaded in online Part I, only four VLC meeting proceedings are enclosed.
5. The copy of FRA certificate uploaded in the designated place along with the annexure having area is only 4.235 ha while the area proposed for diversion is 4.088 ha. The State Govt may correct the area in FRA certificate and all annexure and revised FRA may upload in online Part I.
6. The CA scheme provided with the proposal is for area 7.84 ha while it should be for double the area proposed for diversion i.e. 8.176 ha area. The State Govt may provide revised CA scheme.
7. As per Decision Support System (DSS) Analysis the area of CA shown in KML file of CA in Part II shows the extent of area as 6.31 ha instead of 8.176 ha area proposed for CA. May upload KML file again showing the correct extent of area proposed for CA. in addition out of total area of 8.176 ha proposed for CA, 4 ha is on moderately dense forest. State Govt may replace this 4 ha area with some other area suitable for CA and provide/upload revised digital map, SoI topohsheet map and KML file of the complete 8.176 ha CA area again after making the above change.
8. The area having 0.4 density as mentioned in Part I but 0.4 density does not account for very dense forest for which the State Govt had calculated the NPV. State Govt may correct the calculation of NPV.
9. Employment generation detail furnished in online Part I seems inappropriate. The State Govt may review the data and correct data may fill in online Part I, if required.
10. The copy of MoU signed between user agency and the present owner of the land proposed for CA uploaded in online Part I at designated column is not opened. The State Govt may upload it again.
