I wish to inform that the Section 2 proposals under Forest Conservation Act, 1980 for formation /providing BT to the following roads were submitted by the Executive Engineer, Panchayat Raj, (PIU), Vizianagaram in the reference 1st to 3rd cited for seeking stage-I approval.

SL. No.	Location of the road
1	Neelamvalasa to Gummidiguda of Pachipenta mandal
2	Roddavalasa to Kankanapalli of Pachipenta mandal
3	Kuntam road to Thummiguddi via Mettaguddi of Pachipenta mandal

The above three road proposals were submitted to the Government by the Prl. Chief Conservator of Forests, A.P. Guntur in his letter No.EFS02-15034/62/2020/FCA SEC-PCCF/FCA-3, dated: 02.03.2021, No.EFS02-15034/63/2020/FCA-SEC-PCCF/FCA-3, dated: 02.03.2021 and No.EFS02-15034/61/2020/FCA-SEC-PCCF/FCA-3, dated: 02.03.2021.

In this connection, the Prl. Chief Conservator of Forests, A.P. Guntur in the reference 4th cited has stated that the Government of Andhra Pradesh in Memo No.961/Sec.II/2021, E.F.S.&T (Sec.II), Department dated: 03.05.2021 have stated that as per 4.4 of Chapter-4 of Comprehensive guidelines issued by Government of India, Ministry of Environment and Forestry and C.C. , New Delhi in F.No.5-2/2017-Forest Conservation Act, 1980, dated: 28.03.2019 related to General approval for public infrastructure projects in LWE Districts has expired on 31.12.2020 and therefore, exemption of provision of C.A. for such projects is not applicable presently it is requested that non-Forest area for compensatory afforestation may be identified and

the details of the same may be submitted including map, DGPS co-ordinates, KML file, CA scheme, site suitability certificate etc, for further consideration of the proposals. (A copy of Prl.C.C.F., A.P. Guntur Rc.No.EFS02-15034/62/2020-FCA-SEC- PCCF/ FCA-3, dt: 27.06.2021 is enclosed herewith).

Hence, the user agency is requested to furnish the details of non-Forest area for suitable for compensatory afforestation along with the details of location map, DGPS co-ordinates, KML file, CA scheme, site suitability certificate etc, to this office for onward submission to Prl. Chief Conservator of Forests, A.P. Guntur through Conservator of Forests, Visakhapatnam at the earliest.


