I wish to inform that the proposal (Part-I) for diversion of 6.71 hectares for formation of road from Diguvasembi to Thonam road via Dippalapadu of Saluru mandal in the reference 7th cited have been verified and found difference between the authenticated map communicated by the Prl. Chief Conservator of Forests, A.P. Guntur.

During the field inspection conducted with Forest Range Officer, Saluru, Dy. Executive Engineer, Saluru and Assistant Executive Engineer, Saluru on 28.06.2021 it is found the following deviation in the required Forest area with reference to the Authentication map and part-I proposals furnished by the user agency.

Hence, it is hereby requested to edit the Part-I proposal in the online accordingly, so as to keep the proposed area for diversion same. (eg: Reducing width to 6.82 meters means 6.82 meters x length 5364 meters = 3.66 hectares). Also refer to reference No.8th cited according to which CA land is required now for these proposals (> 1 hectare), therefore in Part-II proposal at

PARIVESH portal the details of C.A. land are mandatorily required. Hence you are requested to clearly provide the information about C.A. land identified for filling information online about details of C.A. land /C.A. Scheme etc.,
