Diversion of 1.61ha of forest land in favour of Baddi Barotiwala Nalagarh Development authority, EPIP Phase1, Jharmajari, Badi district Solan, Himachal Pradesh for the up-gradation of road in front of ACL factory situated at Bir Plassi Nalagarh, within the jurisdiction of Nalagarh Forest Division Distt. Solan, HP.

Kindly refer to your office letter No.SLN-C-Sale-54/2018/894 dated 31.05.2021 on the subject cited above.

2. The proposal received has been found incomplete. The following shortcomings have been noticed in the proposal, which are to be completed. Proposal folders received are returned herewith. All the requisite documents may please be placed in the proposal folder with proper numbering and index.

1. In reply to point No.1, scientific name of the trees involved have been mentioned but on the portal now only 7 trees have been shown instead of 11 trees. As per enumeration lists 11 trees are coming in the road alignment whereas in online part-II only seven trees have been mentioned/ shown. All the trees coming in the road alignment are required to be mentioned against column No.4(ii). Further, the road has been proposed by BBN authorities, hence cost of 11 trees are also required to be calculated.
2. In reply to point No.4, now the detail of patch has been uploaded. But while calculating the forest area of CA patch, it is coming 4.90 ha instead of 3.22 ha forest area proposed for CA. Revised KML file of CA site is required to be uploaded.
3. In reply to point No.8& 9, it has been submitted that Part-II and III have been uploaded but these parts have not been uploaded. These parts can not be uploaded now and will be get uploaded with the help of Nic cell of MoEF &CC, GoI. Hence the PDF of part-II and part-III are required to be submitted so that the same could be get uploaded on the portal.
4. In reply to point No.9, now a photocopy of part-III has been supplied with the reply. Original copy of part-III(in duplicate) are required to be submitted for placing in the proposal folders.
