While forwarding the proposal vide your aforecited Memo under reference, you have reported under 1. Brief description of the Project that, "For setting up the proposed Project, Iron ore Grinding, De-Sliming [Beneficiation] Plant & Slurry Pumping Station and Water Intake System, IDCO has handed over the possession of already leased out land measuring 74.304 Ha of land(20.585 ha. Non forest land recorded as forest as on 25.10.1980 + 53.719 ha. Non-forest) situated in the villages of Gobardhanpur, Bhagalpur, Sialijoda and Lahanda in favour of M/s JSW Utkal Steel Ltd vide his letter no. IDCO/LAE-4012-17/12878 dated 21.06.2018. The said land has been lease out by IDCO vide a registered lease deed No. 11031800324 on dated 23.06.2018".

In the above context, please examine the circumstances under which the possession of the land measuring 74.304 ha having 20.585 ha. of Non forest land recorded as forest as on 25.10.1980 was handed over to JSW Utkal Steel Ltd. by IDCO vide their letter No. IDCO/LAE-4012-17/12878 dated 21.06.2018 alongwith the legality of leasing out the said land by IDCO in favour of JSW Utkal Steel Ltd. vide a registered lease deed No. 11031800324 on dated 23.06.2018 and furnish your report to this office immediately.
