
Sir,

With reference to the subject cited above, you have uploaded FORM-A (Part-I) in PARIVESH web portal for diversion of 302.329 Ha. of Forest Land for construction of Khurda Road – Bolangir New BG Rail Link from 143.33 Km. to 180 Km. and on scrutiny of the FORM-A (Part-I) following discrepancies are noticed.

1. In Point **B.2.1 Details of Divisions involved & B.2.2 Details of District involved**, the area of the forest land & Non-Forest land involved is mentioned 292.289Ha. & 161.766Ha. instead of 302.329Ha. & 205.89Ha. in respect of Boudh Forest Division & Boudh District respectively.

Hence, you are requested to make necessary correction on the above points and re-upload the same in the PRIVESH web portal and also submit the hard copies of diversion project proposal to this office as soon as possible for further course of action at this end.
