Please refer to the Government of Manipur letter No. 27/51/2021-For & Envt dated 17th June, 2021 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The State Govt. is requested to provide following additional information for further processing of the case: -

- 1) To submit scanned SoI toposheet after be duly signed by DFO concerned.
- 2) Certificate for non-availability of non-forest land for CA to be submitted from the Chief Secretary as the proposal is by Private agency.
- 3) FRA certificate to be re-submitted for an area of 5.5 ha in favour of Norem Enterprises as the submitted copy is for an area of 5.0 ha of M/s Sanjit Stone Mining and Crusher.
- 4) The current status of Environmental Clearance.
- 5) To clarify whether the Safety Zone area of 0.71 ha is included in the proposed area for diversion.
- 6) The financial outlay submitted in the proposal is Rs. 16.008 lakhs whereas in the Year-wise Physical and Financial Target is Rs.58.6188 lakhs. State Govt may clarify.
- 7) The financial outlay for CA over an area of 0.73 ha at Rs. 0.679 lakhs has not been included in amount submitted in the forwarding letter as the CA area submitted is only over an area of 11.00 ha at Rs. 16.008 lakhs. State Govt may clarify.
