Sub:- APFD - F(C) Act,1980 - Proposals for diversion of forest land for formation of roads under LWE Category in Narsipatnam Division - Request to furnish CA land details, KML files, Soil suitability certificate etc., for further consideration - Reg.

Ref:- PrI.CCF(HoFF),A.P., Guntur Rc.no.EFS02-15034/62/2020-FCA-SEC PCCF/FCA-3, dt.27.06.2021.

It is to inform that, in the reference cited(copy enclosed), the PrI.CCF(HoFF),A.P., Guntur has communicated the Government of Andhra Pradesh memo no.961/Sec.II/2021, EFS&T (Sec.II) Dept., dt.03.05.2021 stated that as per 4.4 of Chapter-4 of Comprehensive guidelines issued by GoI, MoEF&CC, New Delhi in F.no.5-2/2017-FC, dt.28.03.2019 related to General approval for public infrastructure projects in LWE Districts has expired on 31.12.2020 and therefore, the exemption of provision of CA for such projects is not applicable presently. Further, the GoI, MoEF&CC, New Delhi have clarified that the existing above guidelines are withdrawn vide F.no.11-09/1998FC(PT)-Part(1), dt.10.05.2021.

In this regard, the Executive Engineer, PRI Division, Paderu is requested to identify non-forest land for CA and submit the same including map, DGPS co-ordinates, KML file, CA Scheme, site suitability certificate etc., for further consideration of the following proposals.
