Sub: Proposal for diversion of forest land for construction of operational track from Chand (Bend) to SEB in J.V. Forest Division

Ref: Online proposal No. FP/JK/ROAD/146352/2021.

This is with reference to the above proposal. The Conservator of Forests, North Circle Sopore/DFO J.V. Forest Division/User Agency are requested to upload the following documents, within three days:-


1. Name of the component need to be given by user agency under column B.2.4(Sr.No.1) in Part-1 of Form-A.
2. FRA approval granted by Deputy Commissioner concerned require to be uploaded under Column K in Part-I by user agency.
3. An authenticated coloured layout plan need to be uploaded by user agency, as the uploaded one at additional document is un-authenticated photocopy.
4. In Part-II, under column 4, density is given as 70 instead of 0.7. Correction required from DFO's end.
5. Under column 13(i) name of the Forest need to be given in Part-II by DFO J.V. Forest Division.
6. In the CA Plan, NPV assessed at per old rate of NPV. Correct NPV need to be incorporated in the CA Plan by DFO J.V. Forest Division.
7. The documents under column 13(iii), 13(iv), gives the proposed alignment instead of the map of CA site. SOI toposheet and geo-referenced map indicating the CA site need to be uploaded in Part-II by DFO J.V. Division.
8. Under column 4(ii) at Part-II, the detail of 54 trees/poles/saplings were given. However, enumeration list of same has not been uploaded. Enumeration list of trees need be prepared and uploaded by DFO J.V. Forest Division as per circular instructions conveyed vide No. PCCF/FCA/3124/1739-99 dated 03-08-2021.

9. Specific recommendation as per format of Part II (page no 22-24 of Handbook of forest (Conservation) Act,1980 and Forest conservation Rules, 2003 (Guidelines & Clarification), 2019 MoEF&CC; at SN. 16 of online part-II need to be uploaded by DFO J.V. Forest Division.
