- 3) Acknowledgement copy regarding letter submitted to Deputy Commissioner, Ballari for obtaining of Form-I under Forest Rights Act, 2006.
- 4) Details of CA land identified
- 5) Map showing the details of Protected Areas in 10 Kms radius from the boundary of area proposed.
- 6) All the undertaking should be in ink signed (Original)
