On scrutiny of the above proposal, the following shortfall/discrepancies are noticed. You are requested to depute a responsible person to receive the proposals in 6 (six) copies for necessary compliance at your level and resubmit the same at an early date for further action at this end

- 1. The degraded forest land double in extent i.e.2.023x2 = 4.046 should be identified and a scheme shall be prepared in consultation with the Forest Department and be furnished with the proposal in respect of 2.023 ha of forest area proposed to be diverted. The C.A are shall be pillar posted of requisite size of 30 cmx30 cm and 1.75 meter long and will be embedded at every corner/ turning of boundary line and the pillars will be embedded 0.5 deep in the ground with a foundation of 50cmx40 cm at the cost of UA as per guideline issued by PCCF, Odisha.
- 2. No objection certificate from local bodies i.e. Resolution of Gram Sabha both in English & Oriya version duly countersigned by the Collector shall be enclosed with the DP.

3. FRA certificate under ST & Other Traditional Forest Dweller (Recognition of Forest Right) Act, 2006 issued by Collector, Sambalpur shall be enclosed with the FDP.

- 4. The tree enumeration list enclosed with the Forest Diversion Proposal shall be duly signed by the Revenue Authority for authentication as the area is under the book of Revenue Department.
- 5. Any other requirement /shortfall found if any will be intimated after field verification.
