Please refer to the Government of Manipur letter No. 27/54/2021-For & Envt dated 23.06.2021on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The State Govt. is requested to provide following additional information for further processing of the case: -

- 1) SoI toposheet map showing proposed road is to be duly signed by DFO concerned with the starting point and end point of proposed road be depicted on map.
- 2) The avenue plantation Scheme on both sides may be prepared and duly authenticated by competent authority.
- 3) Comment from CWLW on the impact due to proposed construction since presence of rare/endangered/unique species of flora & fauna is found and mentioned in the site inspection report of DFO, Tamenglong.
- 4) Status of Environmental clearance as it is mentioned as required in the forwarding letter submitted by the State Govt.

The above additional information may be furnished at the earliest so as to enable this office to discuss the proposal in the next REC.
