Total Length & area applied in Forest are 16.729 KM & 0.753 ha respectively (Proposal No: FP/RJ/OFC/150679/2021).

1. Not Complied. DCF RTR Karauli has not amendent their Recommendation in which recommendation is not clear. Although Site Inspection report of DCF has not been uploaded.
  2. Not Complied. DCF has not been submitted notification of forest block/Kailadevi Sanctuary /NCS Sanctuary.
  3. Partial Complied. CA scheme without sign for 4.413 ha submitted but in this proposal CA scheme for planting of 1260 plants is required in lieu of 126 trees coming inside the ROW.
  4. Not Complied. DGPS map, GT Sheet map of CA land haare not proper.
  5. Not complied. It has not been specified whether total 126 tree are to be cut or not. Comments from DCF is required.
  6. Not Complied. NPV certificate has not been submitted.
  7. Partial Complied. Village wise area not matched with the proposed diverted area at sr.no. B-2,3 of part I
  8. Not Complied. Segment wise area of KML (2767+1944+792+ 627+ 1008+381+51+175+452=8197) has not been matched with the area mentioned.
