Sir,

Please refer to the State Government's letter No. FOR.732/CONS/2017/Pt/1226-30 dated 24.06.20 the subject mentioned above, seeking prior approval of the Central Government in accordance of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The State Govt. is requeste provide following additional information for further processing of the case: -

- 1) The scanned maps submitted in the proposal and showing the proposed transmission line have signed, hence require re-submission and be duly signed and authenticated by DFO concerned.
- 2) The status of processes and documentary evidence under Forest Right Act, 2006.
- 3) The comment from the Chief Wildlife Warden as the list of fauna submitted in the proposal n about the presence of Elephant in the area proposed for diversion.
- 4) The State Govt may clarify the submission of two CA schemes i.e. one in Drupong RF with outlay of Rs. 98,57,900/- and the other in Magoni area under Daflagarh Range with financial out 2,80,35,000/-; both involving 98.0 ha.
- 5) Distance of the proposed transmission line from the nearest Protected Area.

Apart from the above, as per record available in Regional Office, this instant proposal is subm revised proposal to the proposal for diversion of 48.147 ha for construction of 132 KV Doubl Transmission Line from Biswanath Chariali to Itanagar and 'In-principle Approval' already granted by t vide letter No.3-AN C 026/2019-SHI/ 3557-58 dated 31.01.2019.

In this regard and for further processing of this revised proposal, the State Govt may first seek re the In-principle approval issued by Regional Office vide letter No.3-AN C 026/2019-SHI/ 3557-31.01.2019 and also to cancel the earlier proposal uploaded in the portal, as processing of this revised proposal be possible without revoking of earlier proposal which has been accorded In-principle approval.
