With reference to the above subject this office had forwarded the proposal for diversion of **0.227598 ha.** of forest land for laying Optical Fiber Cable along the RoW of the road in Changlera village Sy. No. 45 & 46, Karpakapalli Sy. No. 63, Saidapur Sy. No. 58 and Karakanahalli Sy. No. 82 in Humnabad range Bidar Division in favour of M/s Jio Digital Fiber Private Limited, Bangalore.

The government of India has raised EDS query in which it is stated that,

- 1) *Since the proposed area in Bidar Forest Division has been revised from 0.227598 ha to 0.310339 ha corresponding changes may be effected in Part-I and Part-II of the proposal along with revised KML files.*

In reply to EDS raised by the Government of India, you have uploaded proposed area maps & KML and you have also replied that changes in the area can be done by FC nodal office as per the monitoring cell email.

After verification of maps uploaded in Part-I by you It is found that, maps and KML uploaded in Part-I is not as per site inspection report, few survey numbers and area are missing.
