Also in case any power lines are to be drawn through the forest area for pumping of water, the same need to be included in the proposal. Accordingly, the | The DCF, Dandeli Wildlife Division has submitted only the recommendation and impact of project. |

proposal may be revised with the corresponding KML files, the dimensions and drawings of the proposed weir may also be furnished.

Further, since proposed area is part of Anshi-Dandeli National Park recommendation of Standing Committee of the NBWL is also required for processing of the proposal under FC Act, 1980.

**Action to be taken:**

- The User Agency/ DCF needs to submit recommendation of standing committee of the NBWL.
- The DCF needs to submit clarification regarding power lines are to be drawn through the forest area for pumping of water.

Hence, vide ref (1), you are hereby directed to submit the information/ documents /clarification in regard to the above mentioned points to this office for further processing of the proposal.
