- A map showing boundaries of PA and its ESZ, and its distance from project site has been provided in hard copy only. However, Geo-referenced map showing all such information is required to be submitted.
- The progressive detail/status of area treated and funds utilized as on date under comprehensive CAT Plan for Satluj Basin is required to be submitted.

Since NPV rates has been revised by MoEF & CC vide letter dated 06.01.2022. Therefore, revised NPV calculation sheet/bill as per revised NPV rates may be provided.

 The FRA Certificate along with all prescribed annexures including all records of consultations and meetings with Gram Sabha(s) and FRC(s) of concerned villages may be provided. Further, the detail of FRA is required to be updated in online Part-I, Para-K as well.

 The revised Cost-Benefit Analysis as per revised NPV rates dated 06.01.2022 and in ratio form is required to be submitted.

Further, this may kindly be ensured that proposal may be thoroughly scrutinized, reviewed and revised keeping in mind the suggestions given by the MoEF&CC, New Delhi vide File no. 8B/HP/01/147/2019/FC, OM dated 13.05.2022 regarding the Hydel projects of Himachal Pradesh. The compliance of above observations is required to be uploaded in PARIVESH portal at designated locations.
