Sub: Proposal for diversion of 14.928 ha of forest land for construction of Sono Barrage Project, Jaida in Baripada Forest Division and Balasore(WL) Division.

Ref: Your letter No.1753 dt.18.05.2016. of FD STR-cum-RCCF Baripada, to your address.

On scrutiny of above mentioned Forest Diversion Proposal following deficiencies are observed.

1. Land Shedule:-

The DFO. Baripada has not shown DLC forest as a separate category(Page-20, 556/DP) in part II & Site inspection report.

2. Tree Enumeration:

Baripada Division:-

- a. Abstract has not been furnished species wise and girth class wise.
- **b.** Tree serial given haphazardly and not continuously.

Balasore Division:-

- a. Abstract has not been furnished species wise and girth class wise.
- b. Enumeration have been done for 65 nos, trees, but abstract has been given for 64 nos, trees (Page-552 to 555).

3. FRA-2006:-

The user agency has not furnished FRA certificate for 5.669 ha. Reserve forest of Baripada Division.

4. C.A Land:-

a. Compensatory Afforestation have been identified in Gochar land in village Daundia and Gohira. Plantation can not be taken up in gochar land unless the Gochar land has been de-reserved by the Collector. It should be clarified whether the process of dereservation of Gochar land has been competed or not. **b.** The DFO, Baripada and Rairangpur has prepared the block Plantation scheme with 9 year maintenance instead of 10 year maintenance. So, the Plantation scheme need to be re casted.

5. General:-

- 1. The Page numbering of the DP is not done properly and separately.
- 2. The Division profile and District profile have not been furnished within DP.

In view of the above, you are requested to comply the above essential details immediately by co-ordinating with the user agency and resubmit the diversion proposal at an early date. The diversion proposal in four sets is returned herewith.
