- Sub: Diversion of 69.58 ha of forest land in favour of Executive Engineer, Karnal, Indri W/S Division, Irrigation & W.R. Deptt., Karnal for remodeling of Augmentation Canal from RD 20 km. to 58.700 km, under forest divison and District Karnal, Haryana (Online proposal no. FP/HR/ IRRIG/41552/2019).

Sir,

I am directed to refer to online proposal forwarded by the Nodal Officer (FCA), Government of Haryana on the above mentioned subject seeking prior approval of the Central Government for diversion of 69.58 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above mentioned proposal of the State Government, the following information/clarifications are still required to be submitted:

- i) In CA scheme the CA area proposed for CA in NFL i.e Chukhana Klin and Seenkh is 7 ha (4.8 + 2.2) whereas in patch wise details at S. no. 10 and 16 in 13(i) of part II it is shown as 8.51 (3.85+4.66 ha).
- ii) Land site suitability certificate of Nuh forest division is not correct. Area required for plantation on NFL land is not given.
- iii) Enumeration list is not complete or correct. Enumeration list is given of 10791 trees instead of 22033.
- iv) Mutate and transfer of non forest land in favour of Forest Department.
- v) DSS Analysis for CA & ACA sites:-
 - a) DSS/ google image it shows that out of 69.58 ha of NFL provided by user agency for CA only 37.51 ha area is available for target plantation. Additional 32.07 ha NFL be provided for target plantation. And accordingly DGPS map, KML file and SOI toposheet of additional land be uploaded and provided.

The details of NFL provided by UA and availability is space as per DSS is as under:

b) DSS/ google image shows that out of 29 ha of degraded forest land provided by State Govt for ACA only 14.5 ha area is available for target plantation. Additional 14.5 ha NFL be provided for target plantation. Accordingly DGPS map, KML file and SOI toposheet of additional land be uploaded and provided.

The details of ACA sites on degraded forest land as provided by UA and availability of space as per DSS is as under:

- c) DGPS map is not properly scanned/ coordinates are not clear for reading due to this CA site verification not done are Nahri Major Dyst., Khera Kuard, Gangtoli rest house of Sonipat range, Jathaana Kiln (Nuh range), Aitmadpur Surplus land, Mithapur Surplis land (Faridabad range).
- d) DGPS map is not matching with KML shape is Thana Kalan Rest House of Sonipat Range.
- e) Incomplete DGPS MAP uploaded CA site name is Gangtoli rest house in Sonipat range.
- f) Repeated CA site name is PF Hanouri Drain in Indri range.
- g) Detail of earlier proposed CA site in another online project number FP/HR/IRRIG/41538/2019 i.e., 0.61 ha. kml in Seenak ,Panipat range .Need to check above table for detail in sr. no. 16.
- h) Plantation activity visible, Concrete structure, encroached land, land under agriculture/non-forest activity visible in most of the CA sites.
- i) Earlier plantation failed in some of the CA site .Need to verify about it from the SG/UA
