I am directed to refer the Government of Uttar Pradesh letter No. 81-2-2022-79/1991 dated 11.03.2022 on the above cited subject. In this regard following shortcomings have been observed in the information submitted by the State Govt.:

- i. The complete compliance of the Ministry's earlier approval issued vide order no. 8-350/1987-FC dt. 30.05.1989 has not been received in this office. The State Govt is again requested to submit the same.
- ii. The area involved is more than 40 ha and therefore the site inspection by CF/CCF is required. The State govt is therefore again requested to submit the Site Inspection Report of CF/CCF.
- iii. The CDs containing the KML file, Geo-reference Map, Topo-sheet etc. pertaining to the CA land and the 185.84 ha area proposed for renewal of lease have not been received in this office. The same are also not available on PARIVESH portal. The same are therefore required to be submitted.
- iv. The State Govt has intimated that the User agency has violated the provisions of FCA,1980 by leasing out 18.2608 Acre forest land. The state govt. may therefore initiate the process of taking action against the said violation and submit report to the Ministry.
- v. The State govt. has still not submitted the valid lease document pertaining to the instant proposal.
