**Sub: Diversion of 39.57 ha. of forest land in favour of Executive Engineer, Karnal Water Services Division, Karnal for Remodeling of Augmentation Canal from km 0.000 to 75.250 "In Reach 58.700 km to 75.250 km " increase the capacity of canal under forest and District Karnal, Haryana (Online proposal no. FP/HR/IRRIG/41469/2019).**

Sir,

I am directed to refer to online proposal forwarded by the Nodal Officer (FCA), Government of Haryana on the above mentioned subject seeking prior approval of the Central Government for diversion of 39.57 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above mentioned proposal of the State Government, the following information/clarifications are still required to be submitted:

- i) CA scheme of Dadhi Bana in Charkhidadri is not uploaded properly. Revised CA be uploaded under column 13 (ii) part II.
- ii) Land site suitability and CA scheme of Abandoned land of irrigation department at village Kheri, Kanlna in Mahendergarh forest division is given of 2500 plants whereas in column 13 (i) s.no 4 it is shown as 8.6 ha. Revised CA scheme, site suitability certificate of 8.6 ha be provided.
- iii) Land site suitability certificate of Jhajjar forest division is not correct. Are required for plantation on NFL land is not given;
- iv) CA scheme and Land suitability of 3 sites of Kaithal division is not correct. In Kharak Minor from RD 120000 to 14000, Land suitability certificate is given of 1.02 ha where as in CA scheme is of 0.625 ha, .In Kailram 30 ft long strip rasta, Land suitability certificate is given of 4.33 ha whereas in CA scheme it is of 2.7 ha, In NainaDones abandoned channel, land suitability certificate is given of 2.26 ha whereas in CA scheme is of 1.4 ha;
- v) CA scheme for plantation in 8.66 ha (NFL) in Karnal forest division i.e. NBK link RD 87500 R.s (3.27 ha), Old Kachhwa Minor (3.66 ha) and WJC Saidpura (1.73 ha) is not provided.
- vi) DSS/ google image shows that out of 39.57 NFL provided by user agency for CA only 27 ha area is available for target plantation. Additional 12.57 ha NFL be provided for target plantation. And accordingly DGPS map, KML file and SOI toposheet of additional land be uploaded and provided.
- vii) Composition of major species existing on the proposed NFL for CA and ACA with details of their nature whether planted or naturally grown.

The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.
