अतः उपरोक्त बन्दुओं के अतिरिक्त EDS में उल्लिखित अन्य बिन्दुओं की सूचना यथास्थान अपलोड करते हुए आनलाईन व आफलाईन इस कार्यालय को उपलब्ध करने का कष्ट करें, ताकि प्रकरण पर अग्रेत्तर कार्यावाही की जा सके। भारत सरकार का EDS संलग्न कर प्रेषित किया जा रहा है।

**PROPOSAL NO. FP/UK/ROAD/19093/016**

1. In the geo referenced digital map of the area proposed for diversion, uploaded at C (iv) Part I online, geo coordinates are shown in google map which does not serve the purpose. May upload scanned copy of clear GIS software generated geo referenced digital map to the exact scale of the proposed road showing geo coordinates at 200 to 300 m interval along the alignment including all turning points.
2. Village Level committee (VLC) proceeding is provided with the FRA certificate in online Part I only for village "Niloti" while forest area of two villages is involved in the diversion. The State Govt may provide/upload VLC proceeding for other village "Dubad" also.
3. The digital map of area proposed for CA is provided on google earth map which does not serve any useful purpose May provide/upload GIS software generated geo referenced digital map of the area proposed for CA providing geo coordinates at all corner points in shape (polygon/closed area) file.
4. Density in view of the tree proposed to be felled in the proposal is not correct though the rate of open forest for NPV calculation is appears to be correct. The State Govt may review the density.
5. The Muck disposal according to the component wise break up proposed in the forest area which is 0.22 ha also included in the area proposed for diversion. The State Govt may also provide geo-coordinate of the area marked for muck dumping along the alignment in the geo-referenced digital map uploaded for the area proposed for diversion.
6. As per Decision Support System (DSS) analysis, out the total area of 5.20 ha proposed for CA, 2 ha is on moderately dense forest. State Govt may replace this 2 ha area with some other area suitable for CA and provide/upload revised digital map, SoI topohseet map and KML file of the complete 5.20 ha CA area again after making the above change.
7. The State Govt may also provide hard copy of the revised document in original including authenticated copy of Part I, II, III, IV and V as in online web portal to this office through the State Govt.
