4. VLC meeting proceeding for gram 'Juna' Reserve is not submitted.
Action Required:- State Govt. may submit the original hard copy of VLC meeting proceeding for gram 'Juna' RF
5. CA scheme not found uploaded.
Action required: - State Govt. may upload the CA scheme at para 13 online Part II.
6. Hard copy of part III, IV & V is not submitted.
Action Required: State Gove. may submit original hard copy of Part I to V.
