सन्दर्भ: पंजाब सरकार, के पत्र संख्या FCA/1980/269/2018/178 दिनांक 24.06.2019 महोदय,

मुझे आपका ध्यान उपर्युक्त विषय से सम्बन्धित संदर्भाकिंत पत्र की ओर दिलाने का निर्देश हुआ है, जिसमें वन) संरक्षण (अधिनियम 1980 की धारा 2-के अनुसार गैर वानिकी उद्देश्य के लिए 31.42 हेक्टेयर वन भूमि कि मांग की गई है | प्रस्ताव को इस कार्यालय में वन) संरक्षण (अधिनियम 1980-के नियमों के अनुसार विश्लेषण किया गया और पाया गया की इस प्रस्ताव में निम्नलिखित जानकारियों की कमी है जिन्हें शीघ्र जवाब भेजने का कष्ट करें |

- 2. अतः प्रस्ताव से सम्बन्धित निम्नलिखित जानकारी भेजने का कष्ट करे:-
 - (i) Musharba or Fogli Island is to be removed from the proposal, wherever appearing in the proposal;
 - (ii) UA/SG to provide Digital Elevation Model (DEM) of the proposed site for hetter understanding of the slope & drainage system/pattern;
 - (iii) Change in area of the proposal post the removal of Musharba/Fogli Island.
 - (iv) Revised KML file of revised project site to be uploaded and accordingly DGPS be uploaded and hardcopy to be submitted after deleting Musharba Island alongwith layout plan;
 - (v) Elaborate justification to be submitted for locating the proposal in the area;
 - (vi) The proposal area and the adjoining forest area in the vicinity of the project to be demarcated with different colors in KML file;
 - (vii) Existing guidelines used for describing cost benefits of the project to be suitably revised and properly quantified and C-B ratio to be indicated;
 - (viii) Persons working under project may be divided in construction and operational phase;

- (ix) The quantum of number of people employed both permanent and temporary to be reworked;
- (x) The EC submitted by the User Agency is for the old proposal over an area of 123.68 ha. The UA stated that since the present proposal is a smaller version of the earlier EC, hence the same may be excepted. The REC decided to refer this matter to SEIAA, Punjab for clarification;
- (xi) ACA area to be filled in S.No. 13 (i) 3 under Part-II.
- (xii) In Part-II, vulnerability to erosion has been mentioned as NIL. REC opined that this cannot be accepted. This part to is to be modified;
- (xiii) Date of issuance of EC to be inserted in Part-1.
- (xiv) DFO to explore the possibility to get CA site (NFL) in contiguous patch with forest;
- (xv) CF to revisit the proposed area and offer his comments with duly filled in revised proforma;
- (xvi) The user agency has submitted that a report from Chief Wildlife Warden on mitigation plan have been sought which may be submitted.
