उपरोक्त सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरांत निम्निलिखित कमियां पाई गयी हैः

- 1. The following documents are not uploaded in Online Part-I.
 - (a) Diversion area map at para C (iii) in Sol Toposheet.
 - (b) Geo-referenced map of area proposed for diversion at para C (iv).
 - (c) Justification for locating the project in forest area at Para D (i).

<u>Action Required:</u> The State Govt. shall upload the above mentioned documents duly c/s by DFO in designated places online.

- The information at para E (ii) regarding employment generation appears to be incorrect. <u>Action Required:</u> The State Govt. will review and upload the correct information at para E (ii) regarding employment generation.
- The approximate distance of diversion area from boundary of forest not mentioned at para 7.
 <u>Action Required:</u> The State Govt. will upload the approximate distance of diversion area from boundary of forest at para 7 in online.
- 4. The extent of area detail mentioned at para 13 online Part-II, while plantation scheme for 140 plants is provided by way of CA.
 <u>Action Required:</u> The State Govt. may delete the extent of area detail from para 13 online Part-II and upload the revised plantation scheme at para 13 (ii) online Part-II for 425 plants.
- 5. Copy of Administrative/Financial Approval neither uploaded online and nor provided with hard copy of the proposal.

Action Required:- The State Govt. will submit the copy of Administrative/Financial Approval and also upload the same in online portal.

- The certificate indicating aerial distance of diversion area from the nearest National Parks/Sanctuaries is not submitted.
 <u>Action Required:-</u> State Govt. may provide and upload the certificate showing aerial distance of area proposed for diversion from nearest parks/sanctuaries duly authenticated by DFO.
- 7. Detailed layout plan not provided in hard copy by the State Govt. Action Required:- State Govt. will submit the detailed layout plant in hard copy to this office.
- 8. NPV is calculated for class V, however it does not appear correct as per the tree enumeration provided/upload with the proposal.

Action Required:- State Govt. will revise & submit the NPV calculation in view of the tree enumeration.

- In Village Level Committee it is mentioned that the proposal is for police post and residence, while the residence are not permissible as per prescribed guideline of FCA, 1980 in forest land. <u>Action Required:-</u> State Govt. will clarify the same.
- Certificate to the effect that no residence would be constructed.
 <u>Action Required:</u> State Govt. will submit the certificate to the effect that no residence would be constructed in the forest land proposed for diversion.
- NOC of Gram Sabha is not submitted by the State Govt.
 Action required:- State Govt. may submit the NOC of Gram Sabha to this office.
